

Our system also permits doctors and nurses who are seeing multiple patients at the same time to have each patient's electronic chart open for review and notes at the same time (with only one in the foreground and the other available with one click of the stylus on the bottom or top of the screen), so that they can quickly switch back and forth on their tablet PCs or other devices without waiting for one file to close and another to open.

ARRA, also commonly referred to as the Stimulus Act, earmarked over \$40 billion to increase the use of Electronic Health Records by physicians, hospitals and other health care providers.
